<u>Create Brave Space not a Safe Space. A</u> 'safe place' assumes that there is no risk involved, as opposed to a 'brave space', where people are expected to take risks. By encouraging bravery it encourages people to speak up and ask questions, add their opinions, and share their feelings.

Overview of Neighborhood Organizations & City of Minneapolis and how neighborhood orgs fit

• Sarah provided a brief history of neighborhood associations including changes in funding, and priorities, throughout time. She explained that originally (about 30 years ago) neighborhood groups were told to identify community issues and solutions, including neighborhood improvements, to hold an annual meeting, and to have a public election of board members, and that 52% of their funding was mandated to be spent on housing. The City has broadened their requirements on neighborhood groups and now acts more as a funder with a deep list of requirements. The focus and funding is now targeted at equitable engagement.

Values & Role of Neighborhood Associations & LNA

LNA Mission Statement: The mission of the Lyndale Neighborhood Association is to be the vehicle for our community members to shape their neighborhood. Our vision is to engage our diverse community members to build a safe, vibrant, and sustainable neighborhood.

 - Board of Directors duties: duty of loyalty, duty of care, and fiduciary duty. Note: As long
 as these are upheld in good faith the Board of Directors is fairly safe from being found
 accountable for acts of the organization, but just in case LNA also has Directors and
 Officers coverage to protect the individuals serving on the board.
 - Section 3. President. The President shall have general active management of the business of the corporation, and when present, shall preside at meetings of the board and of the members and perform other duties prescribed by the board.
 - Section 4. Vice President. In the absence of the President, or in the event of his or her inability or refusal to act, the Vice President shall perform all the duties of the President, and when so acting shall have all the powers and restrictions of the President.
 - Section 5. Secretary. The Secretary shall ensure that the corporation's records and
 minutes are maintained and perform such other duties and exercises such other powers
 as may from time to time be imposed upon that position by resolution of the board.
 - Section 6. Treasurer. The Treasurer shall ensure that accurate financial records are kept for the corporation and upon request, provide the President and the board an account of transactions by the Treasurer and of the financial condition of the corporation.

Board Officer Elections

Reckel nominates and then moves to place Herkenhoff as President; Janezich seconds. Reckel is nominated as VP. Larson moves this nomination and Gertcher seconds. Larson nominates himself as Secretary. Janezich seconds. Reckel nominates Janezich for Treasurer and Montrose seconds.

All motions were passed unanimously.

LNA Budget: Board responsibilities as it relates to budget and \$\$

An overview of the LNA Budget (current or 2022) is not available. Getting financial documents and information has been challenging. The vision, coming from the Executive Director, is creating a budget that looks for growth of the organization in the coming year both in our program service fees, in outside non-governmental grants, in grassroots fundraising, and through partnerships.
