<u>LNA Reported Crime Stats and Court Cases by Kerri Johnson – 5th Precinct City attorney:</u>

28 auto thefts/auto parts thefts (20 days of March - still very high).

6 auto recovered.

8 thefts/robberies

5th Precinct – Lt. Chuck McCree:

No more auto thefts "club" available; trying to get more.

P.A.L. (Police Activities League) not up and running yet.

Spike in auto thefts/jackings predominately done by juveniles, which are referred to one judge.

Probation Officer Presentation by Eric Hildreth:

Approximately 20 thousand people on parole, 860 juveniles

Probation cases are selected from a city-wide list based on risk assessment.

Conditions of probation are set by the court.

Probation violators can be arrested by probation officer as an officer of the court and probation can be extended.

There are many resources for people on probation from the city and county and they can be used for community involvement.

Eric was thanked for his presentation and service.
